

END-USER LICENSE AGREEMENT FOR **TOPCOAT**. IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THE INSTALLATION: **RHEOLOGIC LTD** End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity, referred to as "licensee") and **RHEOLOGIC LTD** for **TOPCOAT** which may include associated software components, media, printed materials, and "online" or electronic documentation (referred to as the SOFTWARE). By installing, copying, or otherwise using the SOFTWARE, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and **RHEOLOGIC LTD**, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use the SOFTWARE.

The SOFTWARE is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The SOFTWARE is licensed, not sold.

## **1. GRANT OF LICENSE.**

The SOFTWARE is licensed as follows:

### **(a) Installation and Use.**

**RHEOLOGIC LTD** grants you the right to install and use copies of the SOFTWARE on your computer running a validly licensed copy of the operating system for which the SOFTWARE was designed [namely Windows 2000, Windows 2003, Windows XP, Windows ME, Windows Vista and Windows 7 with Microsoft's Dotnet framework 2.0 or higher].

### **(b) Backup Copies.**

You may also make copies of the SOFTWARE as may be necessary for backup and archival purposes.

## **2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.**

### **(a) Maintenance of Copyright Notices.**

You must not remove or alter any copyright notices on any and all copies of the SOFTWARE.

### **(b) Distribution.**

You may not distribute registered copies of the SOFTWARE to third parties. Evaluation versions available for download from RHEOLOGIC LTD's websites may be freely distributed.

### **(c) Prohibition on Reverse Engineering, Decompilation, and Disassembly.**

You may not reverse engineer, decompile, or disassemble the SOFTWARE, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

### **(d) Rental.**

You may not rent, lease, or lend the SOFTWARE.

### **(e) Support Services.**

RHEOLOGIC LTD may provide you with support services related to the SOFTWARE ("Support Services"). Any supplemental software code provided to you as part of the Support Services shall be considered as part of the SOFTWARE and subject to the terms and conditions of this EULA.

### **(f) Compliance with Applicable Laws.**

You must comply with all applicable laws regarding use of the SOFTWARE.

## **3. TERMINATION**

Without prejudice to any other rights, RHEOLOGIC LTD may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the SOFTWARE in your possession.
